

Governance

- Updated and approved Constitution and Rules of Operation

New IUCN Director General

Bruno Oberle was appointed IUCN's new Director General in July 2020, succeeding Inger Andersen. Dr. Oberle brings over 40 years of experience to IUCN at a time when redefining humanity's relationship with nature is more urgent than ever. Frank Hawkins, IUCN US Director stepping down; search for new Director underway

After 8 years as the Director of the IUCN North America Office, Dr. Frank Hawkins will be departing in April 2021. Until about 2007, Frank worked primarily in Madagascar for about 20 years with CI and other NGOs, where he conducted research on birds, lemurs and carnivores, and supported the government, local communities and local NGOs in implementing the National Environmental Action Plan. It is therefore fitting that he is headed back to Madagascar to continue his work with IUCN on policy related issues. An active search is ongoing for a new Director for the IUCN North America Office. Once in place, an announcement will be made to all members.



IUCN World Conservation Congress

IUCN and the French government have agreed to hold the IUCN World Conservation Congress 2020 from 3 to 11 September 2021 in Marseille. The event, originally scheduled for June 2020, was postponed due to the COVID-19 pandemic. More information can be found here.

IUCN Nature-based Solutions Standard

In July 2020, IUCN launched a Global Standard providing the first-ever set of benchmarks for nature-based solutions to global challenges. The new IUCN Global Standard will help governments, business and civil society ensure the effectiveness of nature-based solutions and maximize their potential to help address climate change, biodiversity loss and other societal challenges on a global scale.
